**NATURE AND SCOPE OF WORK:** The Fisheries Operations Manager will undertake duties to manage Kitsumkalum Fisheries and Fisheries programs. In consultation with the Kitsumkalum Band Council, Kitsumkalum Waap (traditional house groups) and Fisheries and Oceans Canada, this position is responsible for the coordination, development and management of the Kitsumkalum Fisheries Management Plan. This position also actively leads the planning and organizing of fishery programs to monitor, protect and sustain the Fishery resource and habitats to ensure food security.

In consultation with the Kitsumkalum Band Council, Kitsumkalum Waap, this position manages the annual schedule of Fisheries for salmon, groundfish and other fisheries resources and oversees compliance with Kitsumkalum Fisheries Management Plan and Regulations.

The successful candidate will be directly involved with building a team of personnel to manage and research freshwater and marine fish, wildlife, and address other environmental issues within the Kitsumkalum First Nation's territory.

The Fisheries Operations Manager will have opportunities to work with and receive direct support from scientists, managers and analysts at LGL Limited Environmental Research Associates. LGL is one of North America's premier environmental consulting firms with extensive expertise in fish and wildlife research. LGL has been working with Kitsumkalum for more than 20 years.

- Develop business plans and seek funding for capacity building initiatives within the Kitsumkalum First Nation
- Write grants to support fisheries and environmental research
- Execute studies of fisheries and environmental research projects
- Assist with fisheries related studies and monitoring programs in support of Kitsumkalum's Consultation and Referrals Department
- Present and provide technical advice on fisheries initiatives and opportunities to the Chief and Council as well as associated umbrella organizations/committees for the preservation of resources and habitat
- Serve on the Joint Fisheries Committee and liaise with the Department of Fisheries and Oceans
- Provide technical direction and guidance for fisheries related initiatives in the field

### REQUIREMENTS:

- Minimum Bachelor of Science in Fisheries and Aquaculture or related discipline. Masters of Science preferred
- Excellent written and oral communication skills
- Ability to work on a team and manage team members
- Willingness to occasionally work atypical hours (e.g., >8 hr days, weekends, holidays)
- Must be comfortable working in and around rivers, streams, and the ocean
- A reliable vehicle and a valid Driver's License
